HB 0157 **Relating to Road Rage Reduction Act** Sorensen

HB 0161 **Relating to Florida Caregiver Institute, Inc.** Meadows

HB 0177 **Relating to Substance Abuse Treatment** Adams

HIV Testing; prohibits disclosure of positive preliminary HIV test result to any person except as specifically authorized; provides that certain HIV test results are preliminary & may be released in accordance with federal requirements; requires DOH to adopt rules specifying certain info., including maximum time period for reporting sexually transmissible disease; requires DOH to adopt rules governing reporting HIV-exposed infants or newborns, etc. Amends FS. - SB 0188** **Relating to Sexual Battery on Minor** Campbell
Sexual Battery on Minor; provides for time period for commencing civil action based upon act that constitutes sexual battery upon minor to be tolled under certain circumstances; provides that time period for commencing prosecution for sexual battery upon minor does not run during certain specified time periods. Amends 95.11, 775.15. EFFECTIVE DATE: 07/01/2005.
