Unattended Child in Motor Vehicle; provides that offense of leaving child unattended or unsupervised in motor vehicle constitutes second-degree misdemeanor under certain conditions; provides that such offense is third-degree felony if child suffers great bodily harm, disability, or disfigurement; provides penalties. HB 0055 **Relating to Domestic Violence/Employee Leave** Porth

SB 0110 **Relating to Health Ins./Prostate Cancer Coverage** Hill
Health Ins./Prostate Cancer Coverage; creates "Senator Les Miller Act"; requires that health insurance policies, group health insurance policies, & health maintenance contracts provide coverage for annual screening for prostate cancer for men of specified age or older; provides that coverage for prostate cancer screening does not limit diagnostic benefits otherwise allowed under policy; provides finding that act fulfills important state

SB 0162 **Relating to Schools/Human Sexuality** Geller
Schools/Human Sexuality; requires school districts to communicate with parents & others concerning school curriculum re teaching of human sexuality to secondary school students; requires that information describe available procedures that parents may use to review curriculum & methods by which parents may provide comments & offer input to school district. Amends 1003.42. EFFECTIVE DATE: 07/01/2007.

HB 0171 **Relating to Infant Eye Care** Saunders (R)
Infant Eye Care; requires certain eye examinations for infants born in hospitals in state; revises applicability; specifies application of certain penalty provisions; provides that coverage for children under health insurance policies & HMO contracts must include certain eye examinations for infants & children. Amends 383.04,.07, 627.6416, 641.31. EFFECTIVE DATE: 07/01/2007.
